4. The above release is subject to the following conditions:

- i. ATI to utilize funds for the purpose it has been released, i.e. for conducting capacity building training programmes in accordance with the objectives of the Scheme.
- ii. ATI shall mandatorily ensure timely updation of complete details of all the training programmes on the online monitoring portal of Sevottam (<https://ati.darpg.in.net/>).
- iii. ATI shall furnish monthly Achievement-cum-Performance Report in prescribed format by 5th day of subsequent month.
- iv. Copy of the Training Calendar should be shared in advance with DARPG/ Stakeholders

- v. There should be suitable components of training to be conducted at field level including district/sub divisions workshops
 - vi. Focus should be on hiring the qualified resource persons with preference given to subject matter specialists who can provide deeper insights.
 - vii. The curriculum should follow the Model Curriculum, Content, and Andragogy shared by DARPG and ensure that there are components of specialised department wise programmes besides the normal components. An indicative list of specialised components include Urban Town Planning, PWD, Police and PHED Department.
5. The request for release of subsequent installment of approved grant shall be considered subject to receipt of Utilization Certificate in GFR 12 – C (Rule 239 of GFR 2017) for utilization of at least 75% of funds released earlier and compliance of the above conditions.
6. NCGG may comply with the procedures laid down in the Department of Expenditure's O.M. No. 1(18)/PFMS/FCD/2021 dated 09.03.2022.
7. The expenditure involved is debit to Major Head 2070 (Other Administrative Services) - 42.03.31 (GIA General), under Demand No. 74, Ministry of Personnel, Public Grievances and Pensions for the FY 2026-27.
